## 1. LETTERS

The size limit is 3 feet $(900 \mathrm{~mm})$ in length, width and depth combined; the greatest dimension should not exceed 2 feet ( 600 mm ).
In all cases when it is in the form of a roll, the length and twice the diameter combined may not exceed 3 feet 3 inches $(980 \mathrm{~mm})$, nor the greatest dimension 2 feet 8 inches ( 800 mm ).

The minimum dimension for envelopes is $3 \frac{1}{2}$ inches $\times 5 \frac{1}{2}$ inches ( $90 \mathrm{~mm} \times 140 \mathrm{~mm}$ ) with a tolerance of $1 / 8$ inch ( 2 mm ). The weight limit is $4 \mathrm{lbs}(2 \mathrm{~kg})$.

Envelopes which are suited to their contents and are rectangular in shape should be used to ensure easy handling.

Items should be made up in such a way that there is no risk of entrapping other items.
The address should be written on the plain side of the envelope, i.e. the side without the flap.
The right half of the address side of the envelope should only be used for the address and postage.
Postage stamps should be placed against the upper right-hand edge of the envelope. The address should be written legibly in Roman letters and Arabic figures running parallel to the top and bottom edges of the envelope. The address should be written in full giving the correct P. O. Box number, area code (if any), and the name of the delivery area (town or city) destination in capital letters. The return address, complete with P. O. Box number, should either be written at the top left hand corner of the front of the envelope or on its flap. The word "letter" should be written on the left hand side of any item whose size may be confused with items prepared at the printed matter rate.

Envelopes with the coloured bars should only be used for airmail correspondence.
Airmail items mailed in plain envelopes should bear a blue airmail label or stamped "airmail" impression on the address side. Stamps other than postage stamps which may be easily mistaken for postage stamps, i.e. charity stamps, labels or designs, must be placed on the back of the item.

## 2. AEROGRAMMES

The front of the aerogramme must be reserved for the address, prepayment and service labels.

Aerogrammes must not contain any enclosures. If enclosures are discovered, they must be forwarded by surface mail.

## 3. POSTCARDS

No postcard may exceed $4 \frac{1}{\mathrm{~s}} \times 5 \frac{7}{1 / \mathrm{s}}$ inches ( $105 \mathrm{~mm} \times 150 \mathrm{~mm}$ ). There is a tolerance of $1 / 8$ inch ( 2 mm ).

For private cards to be used as postcards, the material must be of ordinary cardboard or paper not less than one hundredth of an inch thick ( 250 micrometers). Postcards must be rectangular in shape and must not have any projections or raised parts. Samples of merchandise must not be affixed to the postcards nor must they be embellished with cloth, embroidery, spangles, or similar material; such cards must be sent in closed envelopes only.
4. BOOKS

Books, Magazines, and Other printed matter,
The weight limits are:
Books - $11 \mathrm{lbs}(5.5 \mathrm{~kg}$ ); Other printed matter - 4 lbs ( 2 kg ).
The size limits are the same as for letters.
Printed postcards must comply with postcard regulations as to size.

## 5. SMALL PACKETS INCLUDING UNSEALED SAMPLES

The maximum weight for small packets is $4 \mathrm{lbs}(2 \mathrm{~kg})$. However, not all countries accept small packets at this weight, some limit the weight to $1 \mathrm{lb}(500 \mathrm{~g})$. Countries with this weight limit include Burma (Myanmar) and Papua New Guinea,

The size limit for small packets is the same as that for letters. Small packets must be sealed in a way that allows them to be opened for inspection without breaking any seal or tearing apart any adhesive surface. They may be tied with string provided that the string can be loosened without cutting it. Samples may also be sent letter postthe weight limit is also $4 \mathrm{lbs}(2 \mathrm{~kg}$ ). A green Customs declaration must accompany all small packets.

The words "Small Packet" in bold lettering must appear on any item prepaid at this rate.

## 6. LITERATURE FOR THE BLIND

The weight limit is $15 \mathrm{lbs}(7.5 \mathrm{~kg})$. The size is the same as that for books, magazines and newspapers. The words "Literature for the Blind" should be written in bold letters on all items in this category. Items sent surface mail are free.

## 7. REGISTRATION

Items for registration are given to the Postal Clerk after the necessary postage has been affixed and the customer is then given a posting receipt. The word "Registered" must be written in bold letters on the front of the item in the top left hand corner.

Items bearing an address written in pencil or composed of initials will not be accepted for registration. The complete address must be written in ink. Any adhesive tape used to close registered items must bear the sender's name, mark, stamp or signature. All categories of letter post may be accepted for registration.

## 8. INSURANCE

Only parcels may be insured.

## 9. COMPENSATION

The limit of compensation for loss of or damage to a registered item is the Bahamian equivalent to the provision set out in the Universal Postal Union's Convention from time to time which is presently 30 SDR ( $\mathrm{B} \$ 43.80$ ).

## 10. EXPRESS SERVICE

Express items must be given to the Postal Clerk after the appropriate postage has been affixed and should not be placed in a posting box. Express items should either bear a special bright red printed label or stamp impression in the same colour bearing the word "Express" in bold letters. In the absence of a label or stamp impression, the word may be written in bold letters.

The Express service is identical to that of the ordinary letter mail service and should not be confused with the registration service. Items in this category only receive special priority delivery service at their destination points.

Exceptional items requiring Registration service may also be given Express service.

## 11. INTERNATIONAL HIGH-SPEED MAIL SERVICE (EMS)

International High-Speed Mail Service (EMS) items are presented to the Postal Clerk at the EMS Counter (Nassau) and the customer is given a posting receipt. EMS is identical to the services offered by the private courier services. These items are specially marked by the Orange and Blue bands of the Express Mail Service and receive special attention and handling throughout their journey. They are hand delivered to their destinations and the delivery period is normally within 72 hours.

## 12. HIGH-SPEED MAIL SERVICE (BAHAMAS)

This service which is presently in operation between Nassau and Freeport operates on the same principles as the EMS except that no posting receipts are given to the customer and delivery is via the post office box system rather than by hand.

## 13. ADVICE OF DELIVERY/RETURN RECEIPT

Items for which the sender requests an Advice of Delivery must bear in bold letters "Advice of Delivery" or the stamp impression "A.R." on the address side. Requests for Advice of Delivery may only be made at the time of posting and the form must be completed by the sender in Roman letters; adhesive self-addressed labels are not allowed.

In the event that the original Advice of Delivery is not returned within a reasonable period of time, a duplicate Advice may be requested. Advice of Delivery is only available for registered or insured items.

## 14. INTERNATIONAL REPLY COUPONS (IRCs)

International Reply Coupons (IRCS) have a cost of $\$ 1.08$ and are exchangeable for postage stamps to the value of the first weight step of a foreign airmail letter item; e.g. an IRC that is to be exchanged for a stamp to the U.S. would be worth 65 c , and to the U.K. 70c. IRCs may be exchanged at this rate for any postal stationery or airmail stamps.

## 15. CIRCULARS

Announcements, notices of meetings, etc., whether posted by charitable or philanthropic bodies, societies, etc., in unsealed covers are charged at the Printed Paper rate.

## 16. PARCEL SERVICES

The make-up requirements applicable to items in the letter post services are also applicable for the parcel services.

## 17. INSURED SERVICE

Parcels which are to be insured must be given to the clerk and the customer is given a certificate of posting. Custom declaration forms must be completed and attached to all parcels.

## 18 ORDINARY PARCEL SERVICE

Ordinary parcels must be given to the clerk and a certificate of posting is obtainable for a fee of 25 c. Customs declaration forms must also be completed and attached to these parcels.

## 19. STORAGE FEES

A storage fee is payable on nearly all parcels which are held by the Post Office Department for thirty (30) days following the despatch of the advice of arrival to the addressee.

## 20. INTERNATIONAL BUSINESS REPLY SERVICE

International business reply service is provided by a few administrations abroad. The senders' administrations despatch reply coupons which are returned to the senders without the addressee having to pay any postage charges. These items should be self-addressed.

## SURFACE - FOREIGN PARCELS

In view of the high cost of handling and despatching foreign surface parcels, it was decided that it was only economical to offer the service to the United States of America due to its proximity and direct shipping routes.

Weight limit - 221 bs (10kg); size limit $3^{\prime} 6^{\prime \prime}$ ( 1.05 meters) in length; 6' 7" (2 meters) in length and girth combined.

## Parcels - Warehouse and Customs Clearance Fees, etc.

1. Warehouse charges on parcels remaining in any post office for more than thirty (30) days after the addressee has been notified that such parcels are available for collection is $\$ 1.00$ per day. Provided that due despatch of notice to the addressee is indicated on such parcels it shall be deemed to be notice for the purpose of the section. Also, within twenty (20) days but not less than fifteen (15) days after the despatch of such notice the addressee shall be further notified that such parcels are available for collection and that they must be collected within thirty (30) days of the despatch of the original notice. Charges may be waived with the consent of the Postmaster General upon the return of the parcel to sender.
2. Customs fee of $\$ 1.50$ shall be charged for each parcel which is delivered and attracts Customs Charges.
3. Customers purchasing insurance from the Post Office are encouraged to also purchase private coverage. The Post Office will not be responsible for any loss occurring outside of the postal service (domestic).
