

ADVANCE ESTIMATES FOR QUARTERLY GROSS DOMESTIC PRODUCT: 2021

The National Accounts Section of the Bahamas National Statistical Institute (formerly the Department of Statistics) is pleased to release its series of Quarterly Gross Domestic Product (QGDP), compiled by both the Production and Expenditure Approaches. The QGDP series include both the nominal (current) and real (constant) prices for the period 1st Quarter 2015 to 4th Quarter 2021.



Graph 1: Nominal vs Real GDP – 1st Quarter 2015 to 4th Quarter 2021

Quarterly National Accounts 2021:

The quarterly GDP trends for 2021, shows the Bahamian economy's gradual recovery after the adverse effects of Hurricane Dorian and the COVID-19 Pandemic. However, it did not regain the same level of GDP as attained in 2019 (see Table1). All quarters with the exception of the first quarter 2021 registered year-over-year increases compared to the previous year. However, the most notable real QGDP growth, of thirty-four percent (34 %), occurred in the second quarter, followed by a third quarter increase of twenty-seven percent (27 %).

The progress in domestic business activity was reflected in the improvement in the successive quarterly outcomes, when comparing each quarter to the previous quarter. Second quarter GDP registered an increase of 17% in real growth, relative to the first quarter. The third quarter real GDP increased by 0.4%, when compared to the second quarter of 2021. This was followed by an increase of 0.8% in the fourth quarter of 2021 compared to the third quarter of 2021.
