The National Accounts Section of the Bahamas National Statistical Institute (formerly the Department of Statistics) is pleased to release its series of Quarterly Gross Domestic Product (QGDP), compiled by both the Production and Expenditure Approaches. The QGDP series includes both the nominal (current) and real (constant) prices for the period 1<sup>st</sup> Quarter 2015 to 4<sup>th</sup> Quarter 2022.

#### **Quarterly National Accounts 2022:**

The quarterly GDP trends for 2022, shows the Bahamian economy continuing to progress toward full recovery after the adverse effects of Hurricane Dorian and the COVID-19 Pandemic. Each quarter of 2022 registered year-over-year increases compared to same quarter in the previous year. However, the most notable real QGDP growth, of twenty-one percent (22 %), occurred in the first quarter, followed by a third quarter increase of thirteen percent (13 %).

All quarters of domestic business activity in 2022 reported more than three billion in real GDP, with the third quarter reporting the highest level \$3.3 billion followed by \$3.27 billion in the fourth quarter. Also of note, the second quarter reported \$3.26 billion and the first quarter \$3.01 billion which were both higher than any quarter in the previous year.
