Continuing Dental Education Credits

A review of the Dental Act, 1989 was conducted during 2006 and amendments were submitted to the Ministry of Health. The Council received the final draft of the amendments in early 2007 from the Office of the Attorney General. A final review was completed and it was anticipated that the new Dental Act would have been passed into law by late 2007/early 2008.

Requirements Continuing Dental Education

<u>DENTIST</u> 30 hours during a two year period

Must include:

- ♦2 hrs of Risk Management (Malpractice prevention, laws, rules, ethics, etc);
- ♦2 hrs of Infection Control/HIV/AIDS Education/Infectious diseases Education; &
- ♦1 hr of Domestic Violence Education, Social Ills and Substance Abuse Education (Minimum 1 hour Maximum 1 hour).

In addition a CPR course at the basic life support level which includes one man, two man and child technique and results in certification or re-certification by the Bahamas Health Association, Bahamas Red Cross or any equivalent entity must be completed.

<u>Dental Hygienists</u> (including Dental Nurses) 18 hours during a two year period

Must include:

- ♦2 hrs of Risk Management (Malpractice prevention, laws, rules, ethics, etc);
- ♦2 hrs of Infection Control/HIV/AIDS Education/Infectious diseases Education: &
- ♦1 hr of Domestic Violence Education, Social Ills and Substance Abuse Education (Minimum 1 hour Maximum 1 hour).

In addition a CPR course at the basic life support level which results in certification or re-certification by the Bahamas Health Association, Bahamas Red Cross or any equivalent entity must be completed.

<u>DENTAL TECHNICIANS</u> 8 hours during a two year period

Must include:

♦1 hr of Infection Control/HIV/AIDS Education/Infectious diseases education.

The Registrar's Report

The Bahamas Dental Council came into existence in 1988 with the enactment of the current "Bahamas Dental Act, 1988". The role of the Council is mainly to regulate the profession and practice of Dentistry in The Bahamas. The Council is made up of seven members appointed by the Minister, acting both in his own discretion as well as in consultation with The Bahamas Dental Association. The four major areas of responsibility for the Council are:

- 1. Registration and licensing of all persons wishing to practice Dentistry in The Bahamas. In this role the Council must carefully and thoroughly evaluate the credentials of all applicants, ie. their academic qualifications, work experience and good standing in their country of residence.
- 2. To insure that the desired established standards of practice are maintained, through publication of Code of Ethics and the mandatory continuing education requirements. A copy of each of these documents are provided by the Council.
- 3. To protect the public against unregistered and unlicensed persons (quacks) and to deal with complaints from the general public regarding any dentist that they feel has professionally aggrieved them in any way.
- 4. To work along with the Associations (Bahamas Dental Associations & the Hygienists Association) to move dentistry forward and keep it current with the ever changing times. In this regard, the Bahamas Dental Council can put forth changes to both the Regulations as well as the Dental Act..

As Registrar of the Bahamas Dental Council, I am accessible to all registered persons under the Act (dentist, hygienist, technicians and nurses) to answer any questions, provide information and to assist in whatever way I can.
