- Participate and follow-up on retrieving submissions and Tenders Board records and ensuring procurement activities are placed on the agenda
- Participate in the evaluation for pre-qualification of the contractors, expressions of interest for short listing, tenders and proposals and preparing the corresponding reports
- Prepare reports and report weekly on project procurement matters to the PIU/Program Coordinator
