

[New Providence, Grand Bahama and Other Family Islands]

The National Accounts Section of The Department of Statistics is pleased to release its inaugural series of Gross Domestic Product (GDP) by Island for 2015 to 2019 compiled by the Production Approach. This represents a marked achievement for the Department as it seeks to enhance the provision of economic statistics to assist in both private and public decision making.

The results of this exercise reveal that, of the 2019 GDP of \$13.578 billion in nominal (current) dollars, New Providence (NP) represented \$10.114 billion (74%), Grand Bahama (GB) \$1.876 billion (14%) and Other Family Island's grouping (FI) the remaining \$1.588 billion (12%).

Graph 2: Nominal GDP by Island 2015 -2019



Production Approach Growth Contributors:

The GDP by Island grouping time series for 2015-2019, revealed that New Providence gained on its overall percentage contribution, moving from a share of 70.5% in 2015 to 74.5% in 2019. Being the main center of economic activity in The Bahamas, the outcome for New Providence was primarily explained by higher levels of construction and tourism activity, as well as gains in economic activity stemming from the relocation of persons from the hurricane affected island to the capital. An examination of the Industrial/Sectoral contributions for New Providence in 2019 reveals broad based increases across all sectors, except Arts & Other Services; Agriculture, Forestry & Fisheries and the Mining, Manufacturing, Electricity & Water sectors. Grand Bahama's overall increase in 2019 was supported by increases in contributions from the Construction and Accommodation and Food Services sectors. Despite a slight decrease in overall percentage contribution, the Other Family's grouping posted expansions in the Art, Other Services, Agriculture,

Forestry & Fisheries and Wholesale & Retail Trade, Transport & Storage sectors. These gains were insufficient to offset the impact of hurricane Dorian and its impact on the island of Abaco.

Methodology:

The methodology involves identifying an *island portion* indicator for each industry which can be used to produce a percentage share. This percentage share is then applied to the Gross Value Added of that industry in order to share it across NP, GB and Other Family Islands. The ability to produce the island data became possible with the introduction of more robust administrative data in 2015, hence the data trend begins in 2015. The methodology will continue to evolve and improve as more viable data sources become available.
