Joint Report of the meeting between representatives of the Government of The Bahamas and of the European Commission

Nassau, The Bahamas, 25 January 2010

The Economic Partnership Agreement between the CARIFORUM States, of the one part, and the European Community and its Member States, of the other part (hereinafter referred to as the "Agreement"), was signed in Bridgetown, Barbados on 15 October 2008, and is provisionally applied as of 29 December 2008.

Article 63 of the Agreement provides that the incorporation of the commitments of The Bahamas in Annex IV (Lists of Commitments on Investments and Trade in Services) of the Agreement shall be effected by a decision of the CARIFORUM-EC Trade and Development Committee.

During 2009 representatives of the Government of The Bahamas and of the European Commission held several technical meetings, which led to the establishment of the list of commitments on investments and trade in services to be incorporated in a decision of the CARIFORUM-EC Trade and Development Committee to be adopted as soon as this body will be able to meet and according to the applicable procedures. A thorough vetting of the lists of commitments will be carried out prior to adoption.

The initialled texts of the draft decision and the list of commitments on investments and trade in services for The Bahamas are appended to this Joint Report.

Having regard to the Economic Partnership Agreement between the CARIFORUM States, of the one part, and the European Community and its Member States, of the other part (hereinafter referred to as the "Agreement"), signed in Bridgetown, Barbados on 15 October 2008, and in particular Article 63 thereof,

HAS DECIDED AS FOLLOWS:

Sole Article

1. Annex IV E and Annex IV F of the Agreement are hereby amended by adding respectively "Appendix IV E The Bahamas" and "Appendix IV F The Bahamas" as set out in Annex I and II to this Decision respectively.

2. The reference to The Bahamas in paragraph 3 of Annex IV E, and in paragraph 6 of Annex IV F are deleted. All other provisions contained in paragraph 1 to 9 of Annex IV E, and in paragraph 1 to 11 of Annex IV F are applicable to The Bahamas.

3. All reservations, limitations or exclusions included in Annex IV E and Annex IV F applicable to the CARIFORUM States and indicated as "CAF" therein are not applicable to the Bahamas.


