ACCOUNTING AND OTHER STANDARDS

The budgetary and forecast data presented in the 2021 Pre-Election Update are prepared using a modified cash basis of accounting and guided by the International Public Sector Accounting Standards (IPSAS) financial reporting under the cash basis. As such, revenue is recognized when received and not when earned; expenditure is recorded in the period it is incurred and paid; and purchases of fixed assets, including immovable property, plant and equipment, are fully expensed in the year of purchase.

Data tables are prepared using the new chart of accounts introduced on July 1, 2019 which allows for aggregation and presentation of the fiscal data according to the International Monetary Fund's (IMF) Government Finance Statistics (GFS) 2014 reporting framework for analyzing and evaluating the performance of the government finances.

As data reconciliation is ongoing, annual data for FY2019/20 and FY2020/21 are subject to change, until audited by the Auditor General; therefore, their status is provisional.

1. MACROECONOMIC FORECAST

Amidst global vaccination efforts, the global rebound from the COVID-19 virus remains uneven, due to varying levels of access to vaccines across countries, the emergence of differing virus strains and vaccine hesitancy. Despite these challenges, global economic growth projections, as prepared by the International Monetary Fund (IMF), stand at 6.0 percent for 2021 and are expected to moderate to 4.9 percent by 2022. For the United States', The Bahamas' major trading partner, the IMF forecasts real GDP growth of 7 percent during 2021—supported by a strong and robust vaccination campaign and federal stimulus packages. The American Rescue Plan, adopted in March 2021, incorporated a stimulus package valued at 8 percent of GDP in support of small businesses, families and employees.

With the US economy recovering from the global economic downturn imposed by the coronavirus, prospects for a rebound of the Bahamian economy remain optimistic. The US economic revival is expected to have a lagged impact on domestic economic aggregates. In its April 2021 World Economic Outlook, five months following the conduct of field work for the December 2020 Article IV report, the IMF's estimated growth in economic output in real terms remains unchanged at 2.0 percent. Over the medium term, inflationary pressures are expected to firm as the economy rebounds. The IMF estimates inflation to remain at 2.0 percent in 2021 and peak at 2.8 percent in 2022 (compared to 2.2 percent previously estimated) before stabilizing at 2.3 percent in 2023 and 2024.

Against this largely unchanged outlook for domestic macroeconomic indicators, this report does not anticipate any changes, at this time, in the medium term macroeconomic forecast presented in the 2020 Fiscal Strategy Report (the 2020 FSR) and the 2021/22 annual budget.

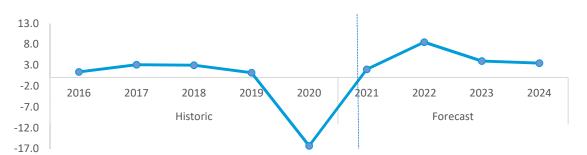


Figure 1: Historic and Forecast Real GDP

2. RECENT FISCAL PERFORMANCE AND OUTLOOK

2.1 FY2020/21 Outturn

Preliminary data on central Government's fiscal performance for FY2020/21 indicate an overall deficit of \$1,348.8 million (see Table 1), which slightly exceeded the budgeted shortfall by \$21.6 million (1.6 percent). In practical terms, there was no material deviation from the projected deficit.

Budgetary operations for FY2020/21 were dominated by the continued adverse impact of the COVID-19 virus on domestic economic performance which necessitated government maintaining extraordinary levels of expenditures to support social and economic assistance programs, health and safety initiatives and operational requirements of several State Owned Enterprises. However, these spending pressures were partially mitigated by the better-than-expected revenue performance. The revenue outturn benefitted from the steady improvement in economic activity during the second half of the year, as the stop-over tourism sector restarted in earnest.

Total revenue for FY 2020/21 settled at \$1,872.7 million—some \$110.1 million (or 6 percent) ahead of budgetary targets. This positive outcome reflected the strengthened rebound of the tourism sector in the second half of the year, with both tax and non-tax revenues surpassing budget targets. Tax receipts of \$1,603.3 million, were 105.9 percent of budget. Relative to the budget, key gains against target were observed in taxes on property, of \$38.7 million (36.9 percent)—aided by the government's tax amnesty program; Value Added Tax (VAT), of \$75.4 million; excise taxes, of \$14.8 million and immigration fees, of \$23.5 million—reflecting the recovery in economic activity; and miscellaneous and unidentified revenue of \$17.0 million, which included gains on the sale of securities held in the sinking fund to settle future foreign currency debt obligations. Nonetheless, reflecting the economic effects of the pandemic on the economy and consistent with earlier expectations, revenue receipts overall were down \$226.5 million (10.8 percent) against the outturn of the previous fiscal year.

Aggregate expenditure firmed by \$322.7 million (11.1 percent) to \$3,220.9 million against the prior fiscal year, boosted by substantial increases in outlays for social assistance benefits (\$196.9 million), finance charges (\$43.0 million), public debt interest (\$77.7 million) and subsidies (\$42.2 million). However, the increase in overall expenditure was partly offset by reductions in spending for compensation of employees (\$65.5 million), supplies & materials (\$18.9 million), services (\$10.3 million), capital transfers (\$55.8 million), other fixed assets (\$15.6 million) and other machinery (\$12 million).

All information for fiscal year 2020/2021 contained in this report are provisional and subject to final audit.

2.2 Fiscal Summary

Over the near and medium term, the broad fiscal targets and strategies remain as outlined in the 2020 FSR and the 2021/2022 budget communication. As originally contemplated, the updated framework reflects the anticipated strengthened rebound of the Bahamian economy amidst the global deployment of COVID-19 vaccines and the corresponding release of pent-up demand created as a result of the relaxation of health and safety restrictions. Accordingly, this report does not anticipate any material deviation from the projections in the Fiscal Strategy Report or the 2021/2022 annual budget presented to Parliament.

2.3 Revenue Forecast

As outlined in the 2021/22 budget communication and Table 3 below, revenue forecasts for the current fiscal year and the medium-term horizon assume the following:

- a gradual rebuilding of revenue, benefitting from efforts to enhance domestic vaccination rates;
- a gradual reduction in COVID-19 stimulus concession programs; and
- an increase in the revenue/GDP ratio from 18 percent of GDP in FY2021/22 to 20 percent of GDP by FY2023/24

In addition to a return to normalized levels, as the impact of the COVID-19 virus dissipates over time, revenues are also expected to be positively impacted by other government programs which include:

- the incremental impact of cruise homeporting opportunities throughout the Bahamian economy;
- enhanced revenue collections amidst continued digitization of government processes and services and improved revenue administration and tax policies.

2.4 Expenditure Forecast

As outlined in the 2021/22 budget communication and in Table 4 below, expenditure forecasts for the current fiscal year and the medium-term horizon assume the following:

- The resurgence of a second and now third wave of COVID-19 in country has necessitated the extension of certain social support programs during FY2021/22. Recurrent expenditure is expected to increase to 23.1 percent of GDP in 2021/22.
- With the reduction in the need for COVID-19 support spending by FY2022/23, recurrent expenditure is anticipated to normalize over the medium term. Recurrent expenditure as a share of GDP is expected to decline to 19 percent of GDP in 2022/23 and further decline to 18.4 percent by 2024/25

2.5 Debt and Borrowing Plan

At end-June 2021, the Government's direct charge stood at an estimated \$9,935.3 million, which equated to an estimated 86.3 percent of GDP. Of the total debt stock, approximately \$5,386.6 million or 54.2 percent was in Bahamian Dollars and the balance of \$4,548.7 million (45.8 percent) in foreign currency—the bulk of which is in United States Dollars.

The FY2021/22 Annual Borrowing Plan, released by the government on July 8, 2021, outlined the annual strategy for debt operations within the context of the \$1,851.9 million aggregate financing requirement approved by the Parliament. See Table 6 for details of the borrowing requirements and prospective financing transactions.

As proposed, the 2021/22 debt strategy contemplates sourcing approximately 48.2 percent of the borrowing requirements from the domestic market and the remaining 51.8 percent from foreign currency sources. Following the conclusion of a competitive Request for Proposal process, the government awarded a mandate to Goldman Sachs, in late July, 2021, to be the book-runner on a proposed US\$700 million bond transaction—of which a maximum tranche of US\$200 million is to be guaranteed by the Inter-American Development Bank. Alongside this bond issuance, the government also intends to pursue a liability management transaction for at least 50 percent of its existing US\$300 million 2024 bond issue.

Since July 1, 2021, to the date of this report, the Government's fund raising activities against the FY2021/22 borrowing authorization totaled approximately \$187.0 million. This comprised \$173.0 million in 91-day Treasury bills, scheduled to be retired out of the proceeds of the prospective international bond issuance; and \$14.0 million by way of new bond issuance. The government also refinanced \$52.3 million in maturing bonds via a combination of new bonds (\$18.1 million) and Treasury bills (\$34.2 million)—activities which do not result in an increase in the outstanding debt.

For the forward years, government's net borrowing is expected to follow the trajectory of the annual deficit as outlined in Table 2 above. Based on this, and assuming that debt repayment is refinanced, the aggregate of prospective borrowings to meet the projected deficits in FY2021/22 through FY2024/25 will culminated in the government's direct charge increasing to an estimated \$11,520.2 million by FY2024/25, which is consistent with the FSR 2020 projections (see Table 2).

CONTINGENT LIABILITIES

Explicit contingent liabilities reported as at June 2021, include guarantees or obligations undertaken by the GBEs that may go unmet and therefore become liabilities of the government. Currently, these liabilities are estimated at \$420 million, the bulk of which are obligations of the Mortgage Corporation (38 percent), Public Hospitals Authority (16 percent), the Water & Sewerage Corporation (16 percent) and the Educational Loan Authority (11 percent).

2.6 Tax Relief, Remissions and Waivers

During the FY2021/22 Budget Communication and debate, the government announced several programs designed to stimulate and accelerate the pace of economic recovery in The Bahamas—primarily covering tax concessions to the Bahamian public and interested investors. The impact of these programs are incorporated in the fiscal projections for FY2021/22 and include the following:

- Launch of a VAT tax credit programme for businesses,
- Small businesses duty concessions programme on the purchase of inventory for new businesses,
- Tax concessions on construction materials and business related expenditures provided to small businesses in eleven (11) Family Islands, and
- Extension of the Real Property Amnesty Programme to eligible applicants to August 2021.

Other than these tax concessions and waivers, there have been no tax remissions granted as at the date of this report.

2.7 Arrears and Accounts Payable

The government continues to liquidate outstanding payment arrears uncovered during FY2017/2018, originally placed at \$362.0 million in the budget for FY2018/2019. As at end-June 2021 the remaining balance stood at \$64.3 million.

Government accounts payables, which include unpaid invoices for government Ministries and Departments reported to the Ministry of Finance as at August 25, 2021 aggregated \$108.8 million. **Annex B** provides the details of all invoices reported to the Ministry of Finance by Ministries and Departments.

The information on Accounts Payable represents the position at August 25, 2021. The Accounts Payable position changes daily as invoices are paid or submitted for settlement. The position as at the reporting date represents the equivalent of 3.4 percent of FY2020/21 total provisional expenditure and less than a half-month's equivalent of average expenditure during the last fiscal year.

3. FISCAL RISKS

Given the continuing impact of the COVID-19 pandemic on global health systems and the inherent risks to the Bahamian archipelago posed by hurricanes due to its geographic location, the fiscal risks to the Bahamian economy remain unchanged from those disclosed in the 2020 FSR.

3.1 Macroeconomic Risks

As disclosed in the 2020 FSR and the 2021/22 Budget Communication, outside of general macroeconomic risks inherent in any fiscal plan, the risk of contractions in the global economy due to the COVID-19 pandemic remain, and the incidence of additional waves of viral spread. These general macroeconomic risks were contemplated in the context of preparation of the 2020FSR and the 2021/22 Budget. As at the time of production of this report, as the domestic outlook has not been revised, government is minded to maintain its current strategy to mitigate this risk.

3.2 Natural Disaster Risk

The Bahamas continues to experience the effects of climate change as the country bears the prospect for stronger and larger hurricanes from year to year. To adequately manage the impacts of climate change and mitigate the risk of disasters across the country, the government maintains several key measures to reduce both the nation's vulnerability and financial obligations in the aftermath of these disasters.

As outlined in the 2020 FSR, the government has a multi-pronged approach to addressing this risk factor, which included the creation of the Ministry of Disaster Preparedness and Reconstruction to improve the framework and protocols for planning, preparation and responding to natural disasters; renewing its line of credit with the Inter-American Development Bank (IDB) for use in defraying the costs of rehabilitation and reconstruction following a severe weather event; maintaining its parametric insurance policy with the Caribbean Catastrophic Risk Insurance Facility; strengthening The Bahamas' resilience to coastal risks through the implementation and adoption of sustainable coastal protection infrastructure and management; and the establishment of a disaster fund with proceeds from the extinguished dormant account funds.

3.3 Disease and Pandemic Management

The government recognizes the need to upgrade the nation's health infrastructure, to ensure that current capacity challenges such as limited bed space and insufficient equipment are addressed. The current budget and forecasted years have allocated necessary resources to shore up the health sector framework for greater health management.

Following the devastation of Hurricane Dorian and the COVID-19 pandemic, which magnified gaps in public health care facilities, the Government has embarked on a significant upgrade to the core health infrastructure, with the sum of \$100 million to be invested during the next 18 months. In 2020/2021, the Government obtained a Multilateral Investment Guarantee Agency ("MIGA")-guaranteed loan from Banco Santander SA of Spain ("BS"), of which \$89.0 million is for modernizing the public health system in New Providence to respond to COVID-19 and build resilience post-pandemic. This funding will provide for an increase in bed capacity in public sector hospitals by 22 percent; the creation of a new infectious disease unit at the Princess Margaret Hospital (PMH), and the expansion of the emergency department at the PMH. In 2021/2022, the Government commenced negotiations for an estimated \$40 million MIGA guaranteed-loan facility from BS (\$19.0 million to be drawn in FY2021/22), to cover the cost of a new climate resilient four story facility, at the Rand Memorial Hospital (RMH) in Grand Bahama. This builds upon the recent renovation works at the RMH which were carried out at a cost of approximately \$18 million.

3.4 Pension Liabilities

The government continues to address its pension obligations and is completing a study on alternative options to address current and future pension liabilities

3.5 Exchange Rate Risk

Exchange Rate Risk is the risk that The Bahamas' debt position will deteriorate due to changes in the Bahamian Dollar relative to other currencies. The Bahamas' exchange rate risk remains limited, as the Bahamian dollar maintains parity with the US Dollar and the government maintains several currency swap arrangements for borrowings denominated in other currencies to mitigate the impact of extreme currency deviations.

THIRD SCHEDULE (Section 11) CONTENTS OF A PRE-ELECTION UPDATE REPORT

- 1) The pre-election update report shall contain
 - (a) updated macroeconomic forecasts and assumptions from the fiscal strategy report or midyear review, whichever is the most recent;
 - (b) updated fiscal information including—
 - Government revenue outturn and forecasts for the current year and next three years;
 - ii. Government expenditure outturn and forecasts for the current year and next three years including for expenditure, primary expenditure and expenditure on wages and related personnel costs;
 - iii. approval of new spending since the annual budget including major investment and service projects and policies;
 - iv. fiscal balance forecast for the current year, fiscal balance for past two years, and forecast next three years;
 - v. net and gross debt for the current year and next three years;
 - vi. level of guarantees;
 - vii. tax relief, remissions, and other waivers;
 - viii. the outstanding stock of arrears for all government entities including showing separately all new unpaid invoices since the stock of arrears was last reported; and
 - ix. other significant financing matters that have occurred or are planned; and
 - (c) an update of the fiscal risk position compared to the fiscal strategy report and the annual budget;
 - (d) a statement of responsibility signed by the Minister that the Pre-Election Economic and Fiscal Update includes
 - all policy decisions with material economic or fiscal implications that the Government has made before the day on which the contents of the Pre-Election Economic and Fiscal Update was finalised; and
 - ii. all other circumstances with material economic or fiscal implications of which the Minister was aware before that day; and
 - (e) a statement of responsibility signed by the Financial Secretary that the Pre-Election Economic and Fiscal Update has been prepared by the Ministry
 - i. using its best professional judgments; and
 - ii. on the basis of economic and fiscal information available to it before the week on which the contents of the Pre-Election Economic and Fiscal Update was finalised;
 and
 - (f) a statement of the accounting and other standards applied which shall be the accounting standards adopted for the Government consistent with internationally accepted standards and where such standards are not used, then an explanation of the deviation shall be provided.

Annex B: Arrears and Account Payable Details by Ministry and Department

Arrears Details

As at end-July 2021, government settled \$297.7 of the facility established to liquidate \$362.0 million in then unreported payment arrears identified in FY 2017/18. The remaining liability balance of \$64.3 million will continue to be addressed over the medium term through the budgetary process. These are reported in the annual budget exercise. Payment categories include Rent Arrears, Outstanding Recurrent Commitments, and arrears related to the National Drug Plan. To service these obligations, budgetary allocations committed for the current fiscal years is \$30.9 million, with \$24.0 million and \$24.2 million forecasted to settle these liabilities for fiscal years 2022/23 and 2023/24, respectively.
