AIDE MEMOIRE AND ANNOTATIONS TO THE MAIN AGENDA ITEMS OF THE 5TH MEETING OF ACP SENIOR FISHERIES OFFICIAL AND MINISTERIAL MEETING

Background and context

- 1. For many ACP countries, fisheries and aquaculture plays a significant role in contributing to food security, livelihoods, and export revenues. In addition to their importance to the economies of many countries in terms of income and creation of employment, fisheries and aquaculture play an irreplaceable contribution towards eliminating hunger, promoting health and reducing poverty particularly for Small Island Developing States (SIDS). Fish also continues to be one of the most-traded food commodities with more than 60 of the ACP States engaged in the export of fishery and aquaculture products. For some ACP states fisheries exports account for half the total value of their traded commodities.
- 2. The ACP regions' maritime zones supports some of the most iconic and productive fisheries in the globe. Proper stewardship of these resources is however confronted by multiple challenges including unsustainable practices arising from inter alia land-based and coastal activities, Illegal, Unregulated and Unreported (IUU) fishing and climate change threatening marine ecosystems, fish stocks, food security and livelihoods.
- 3. The shared nature of fisheries resources means that regional and international cooperation is essential for sustainable utilization and development. Such cooperation is crucial in supporting the implementation of programs modelled on what has worked elsewhere. In this context and to reinforce the key role that fisheries and aquaculture play in the socio-economic development of member states, the ACP Fisheries Mechanism was established in 2009. The mechanism is a platform for promoting new approaches of fisheries governance and cooperation for sustainable fisheries and aquaculture development.
- 4. Up to four high level ministerial meetings have been held whereupon consensus on policy and strategic options have been adopted. Indeed a five year ACP strategic plan of action for fisheries and aquaculture and its implementing roadmap have been adopted. The action plan underlines member states shared commitment to support the implementation of policies and actions geared towards building resilient and productive marine ecosystems, ensuring effective fisheries management systems, sustainable utilisation and trade of fisheries products and promoting investments and innovations in the marine sector for social economic development.

5. The fifth meeting comes after the conclusion of significant global level events that have a bearing on the overall fisheries policy landscape including the historic agreement reached to combat climate change at the COP 21 and the momentous adoption of the United Nations 2030 agenda for sustainable development and the FAO Port State Measures agreement. The meeting therefore provides the ACP fisheries policy makers with an opportunity of reflection and to consolidate their efforts in contributing to the implementation of the agreements and the attainment of the relevant SDGs. The meeting also happens at a fitting moment for many ACP coastal states particularly (SIDS), where the sustainable development of the blue economy is a pillar for accelerated growth of their national economies.

Objective

- The overall objective of the meeting is to provide a forum for a high level engagement of
 policy makers to contribute to improved governance and development of fisheries and
 aquaculture resources for the overall socio-economic development of ACP Member
 States.
- 7. Specifically, the meeting seeks to:
 - Reinforce high level broad based shared commitment on priorities for the sustainable development and growth of ACP fisheries and aquaculture;
 - Take stock of achievements and challenges of implementation of the strategic plan of action for fisheries and aquaculture and define specific policy and strategic interventions to address sectoral challenges;
 - Share national or regional good practices and identify collaborative approaches for replication in other ACP states, mechanisms/regions;
 - Facilitate dialogue and seek consensus on priority issues for multilateral engagement to address issues that undermine fisheries sustainability, for example Illegal, Unregulated and Unreported (IUU) fishing and disciplines on harmful fisheries subsidies;
 - Deepen cooperation and identify areas and strategies to sustain and expand partnerships on fisheries and aquaculture development for the benefit of ACP states;
 - Share experiences gained at the national, regional and international levels in the implementation of SDG Goal 14.

10:00	Session 6: Small, scale fisheries: Securing access to resources and markets
	An important feature of the ACP fisheries is that the small-scale fisheries are a very significant part of the catching sector. The small-scale fisheries sector tends to be firmly rooted in local communities, traditions and values. This represents an important sector which underpins food security, employment, livelihoods, international trade and development. As much as US\$5.3 billion worth of ACP fish exports enter the international market, the greatest portion of these from the small-scale fisheries. Yet, small-scale fishers are faced with significant market access difficulties, in particular, compliance with food standards of export markets, access to resources, and competition from large scale operators.
	This session will deal with the question of securing small scale fisheries access to markets and resources, which is front and centre for many ACP states and clearly prioritized as a key target of the SDG 14. What deliberate actions are required to deal specifically with developing the small scale fisheries sector?

11:15	Session 7: The way ahead for fisheries subsidies reforms
	Certain forms of subsidies provided by governments to the fishing sector are a major driver for the build-up of excessive fishing capacity, thereby undermining the sustainability of marine fisheries resources and the livelihoods that depend on them. The need to develop effective disciplines on fisheries subsidies which contribute to overcapacity and overfishing has remained an important agenda item in the international arena, and more so, with the adoption of Goal 14 of the 2030 agenda for Sustainable Development .
	During this session, in acknowledgement of the urgent need to expeditiously conclude a multilateral agreement to prohibit certain forms of fisheries subsidies, the meeting will deliberate on the following: The state of play of negotiations; Key elements of an acceptable fisheries subsidies reform for ACP countries that allows for sufficient policy flexibility for sustainable fisheries development, and further contribute to refinement of a coherent ACP position on fisheries subsidies reform.
