CUSTOMS MANAGEMENT (AMENDMENT) REGULATIONS, 2014

The Minister in exercise of the powers conferred by sections 354 and 355 of the Customs Management Act, makes the following regulations —

1. Citation and commencement.

- (1) These Regulations, which amend the Customs Management Regulations, 2013¹, may be cited as the Customs Management (Amendment) Regulations, 2014.
- (2) These Regulations shall come into force on the 1st day of July, 2014.

2. Amendment of regulation 8 of the principal Regulations.

Regulation 8 of the principal Regulations is amended by the insertion immediately after paragraph (2) of the following new paragraphs —

“(2A) Notwithstanding paragraph (2), where the Minister is satisfied that a commercial airline has —

- (a) maintained at a minimum three hundred international rotations (take-off and landing);
- (b) demonstrated an increased passenger arrival within the preceding year; and
- (c) paid all outstanding attendance fees,

the Minister may, on the recommendation of the Comptroller, authorize in writing the reduction of the fee payable by that airline to \$2.50 per inward and outward declaration.

(2B) The reduced fee referred to in paragraph (2A) shall be valid for a period of one year and shall be subject to annual renewal.”.

3. Amendment of regulation 147 of the principal Regulations.

Regulation 147 of the principal Regulations is amended —

- (a) by the insertion immediately after paragraph (1) of the following new paragraph —

“(1A) Notwithstanding paragraph (1), where the Minister is satisfied that a commercial airline has —

- (a) maintained at a minimum three hundred international rotations (take-off and landing);
- (b) demonstrated an increased passenger arrival within the preceding year; and
- (c) paid all outstanding processing fees,

the Minister may, on the recommendation of the Comptroller, authorize in writing, the waiver of the fee payable under paragraph (1)(b).”;

- (b) in paragraph (2), by the deletion of subparagraph (b); and
- (c) by the insertion immediately after paragraph (2) of the following new paragraph —

“(3) A processing fee of ten dollars (\$10.00) is payable in respect of Form C14 for the entry of goods imported conditionally duty free under the Hawksbill Creek Agreement.”.

4. Amendment to Second Schedule to the principal Regulations.

The Second Schedule to the principal Regulations is amended—
